# 1 Background discussion

## CPS Community Accountability Forum Transgender Equality Sub Group

- 1.1 This item covered an introduction to CPS policy in relation to Transgender equality over recent years and made reference to:
  - First edition of the Transgender Management Guidance (2006)
  - Homophobic and Transphobic Prosecution Policy and Guidance (2007)
  - Homophobic and Transphobic Crime Toolkit: good practice and lessons learnt (2008)
  - EDU Trans Equality Bulletin 2012
  - Review of Transgender Management Guidance (Started 2011)
  - Trans hate crime assessment 2012
- 1.2 Discussion also highlighted the central importance of:
  - engagement both internal and external
  - under-reporting of hate crime and
  - data collection

#### 2 Terms of Reference

- 2.1 There was detailed discussion of the terms and general welcome for the paper. The terms were agreed with the following suggested amendments:
  - The Purpose of the sub-Group when it was made clear that its work would be reported to the Community Accountability Forum (CAF) which has an external-facing membership and is chaired by the CPS Chief Executive, Peter Lewis.
  - The number of meetings and timeframe appeared appropriate to all members. There was agreement that it would be useful to take stock of progress in the third meeting before deciding on the future of the Sub-Group. At this point, a wider engagement event might also be considered to reflect on progress to that point and any remaining challenges.
  - Whilst the membership drawn from the CAF and from CPS Panels provided a very good starting point, it was felt that extending an invitation to a youth organisation such as Mermaids would be very helpful.
  - The role of CPS members might be widened to include reference to communications, both internal and external
  - This led to a discussion of the different opportunities for keeping others in touch and aware ff the work of the sub-group e.g. Use of EDU infonet page to hold information and updates. It was also suggested that means were considered for anonymised feedback and input, from CPS staff n particular

- Sub-Group members to provide contact details for any Trans media/newsletter
- EDU to provide an initial briefing for the work of the sub-group detailing means and opportunity to input
- EDU to circulate T&S forms
- EDU to consider keeping ACPO lead informed of development
